Guidelines for Application for Renewal of Membership

- A. A letter should be submitted to UCAR from the chief executive's office formally applying for renewal of membership. This letter should confirm:
 - the university's continuing commitment to a full, coherent and integrated program of course studies and dissertation research leading to the doctorate in one or more of the atmospheric sciences or closely related fields; and
 - 2. a continuing commitment to active participation in the affairs of UCAR and/or to collaboration in the program of the National Center for Atmospheric Research.
- B. This letter should be accompanied by seven copies of the following:
 - The most recent submission for the combined UCAR/AMS report, with the following supplemental information: (a) last year each course was taught, and (b) name of instructor for each course.
 - 2. A representative sample of curriculum vitae of the faculty. Curriculum vitae of five to ten permanent faculty members is deemed sufficient.
 - A list of publications by the faculty in the last five years.
 - 4. A list of students awarded the Ph.D. degree in the past eight years with thesis title and current employment, as known.
 - 5. A description of the use of NCAR facilities and participation of students and faculty in UCAR and NCAR affairs in the past eight years.
- C. The renewal applicant is encouraged to provide single copies of printed material describing activities in the atmospheric sciences at that institution.
 - Catalogues and program descriptions.
 - 2. Graduate student brochures.
 - 3. Description of facilities and research.
